Law 25 - Consent to the communication of personal information

Golf and power carts

- Members benefit from the privilege of booking tee times up to 14 days in advance (10 days for visitors). Rounds are non-shareable with guests.
- 4-day members may use their rounds during specific Club-organized events taking place on weekends (with a surcharge).
- 4-day members can play on Fridays before 11:00 AM.
- Remaining rounds at the end of the season are non-transferable and must be used in 2026.
- A round taken from a package or payable immediately (replay) is at 50% of the current rate, based on availability, without a reservation.
- No members are authorized to play on statutory holidays.
- Junior members (17 and under) can play a maximum of 75 rounds during the 2026 season.
- Power cart use must be shared with another person who has paid for a half-cart.
- If a single player wishes to use a golf cart without sharing, they have the option to rent the entire cart by paying the full rental cost, subject to availability.
- Cart drivers must be 16 or older and hold a valid driver's license.
- The renter/user of a cart is responsible for any damage caused to the cart and must pay repair or replacement costs in case of damage.
- Early morning tee times must stay clear of the course maintenance crew. Every member is obligated to convey club regulations to their guests and is responsible for them.

Tee time modification and no-show policy

- Tee time modifications/cancellations must be made no later than 4:00 PM the day before.
- You must register the names of your guests no later than 4:00 PM the day before; tee times without registered names will be cancelled without notice and are non-refundable.
- In the event of a no-show, a green fee will be automatically debited from your account for each person on the reservation.

Dining

- The minimum consumption fee (taxes and service extra) must be spent between the season opening date and the year-end tournament. It is non-refundable.
- Only purchases at the restaurant and bar count toward the minimum consumption amount. Other purchases such as at the pro shop, during tournaments, or on the course are not included in this amount.
- The golf club holds a liquor license; therefore, it is forbidden to bring outside alcohol onto the property.

Payment terms

- All fees related to the membership (round/cart packages and services) are payable by cash, debit, or bank transfer. Credit card payments are not accepted.
- A credit card payment authorization form must be completed at the start of the season and will be used in case of non-payment of your statement or a no-show.
- You must present your membership card at all times to benefit from discounts. Failing that, payment must be made immediately on-site (cash, debit, or credit).
- Indicate your preferred membership card type: Physical Virtual for mobile Both

Rain policy (at the golf club's discretion)

- Fewer than 8 holes: One 18-hole green fee credit.
- 9 – 12 holes: One 9-hole green fee credit.
- 13 holes or more: No green fee credit is granted.
- If the course is closed due to bad weather, no green fee will be debited from the account if the tee time was not cancelled.

Other

- Golf St-Donat reserves the privilege of closing all courses for twelve (12) days during the season for outside events.
- Club life is important at Golf St-Donat, and we wish to offer everyone a pleasant environment. No disrespect toward members, clients, or club employees will be tolerated.
- At the end of the season, hole 18 may have a temporary green. The course will then be adjusted to a par 70 instead of 72.

Personal commitment

 - Participation in sports, conditioning, instruction, dining, and other activities, services, programs, or events provided or organized by the Organization.
4. I am aware that the risks include, but are not limited to, the risk of serious injury, death, or property damage. I understand that the risks may be related to my own state of health (including physical, mental, and emotional) and to the awareness, care, and skills with which I conduct myself.
5. I freely accept and assume full responsibility for all risks and possibilities of injury, death, property damage, or other losses resulting from my participation in the activities described above. I accept these risks and agree to the terms of this waiver and release, even if the Organization is found negligent or in breach of any duty of care or any obligation toward me regarding my participation in the activities.
6. In addition to the consideration given to the Organization for my participation in the activities, I and my heirs, next of kin, executors, administrators, and assigns (collectively my «legal representatives») agree:
 - To waive any claims I have or may have in the future against the Organization.
